1. BIMinNZ Website Analytics

The website visitor numbers decreased in the December period, consistent with previous years. Traffic to the BIMinNZ conference page, however, remained high and the conference is set to take place 8 May. The BIM Network Coordinator is set to update the BIMinNZ website, with new case studies, streamlined navigation and the release of the updated BIM Handbook later in Q1 which should see numbers increase.





2. BAC Budget

The Committee reviewed the BAC Budget for FY18 / 19 and are on track with budget needs which are carefully managed by BRANZ. The Committee was reminded that any funding requests for projects need to be submitted as soon as possible to ensure there are no delays with the approval process.

3. BIM Events

There were no BIM Network events for the December / January period. The next Network meetings are to be held in February with a focus on clients and procurements.

The BIMinNZ Conference will take place 8 May 2019. Registrations are open,

4. BAC Strategy

The Committee have agreed to bring in an independent facilitator to work through the BAC's vision with a ½ day strategy workshop set to take place April 10, 2019. The Chair and Network Coordinator will discuss the BAC's needs and next steps for the workshop with the facilitator.

5. BIM Handbook

The new ISO 19650 BIM standard, which supersedes the previous PAS 1192 standard, was released on Dec 5. Various Committee members and external parties will come together on the 12th of February for the BIM handbook Industry Workshop. This workshop will focus on updating the old Handbook, aligning the ISO and PAS standards, aligning Metadata standards and gather overall comments on proposed changes which will help shape the new BIM Handbook which is set to be release April / May 2019.

6. Case Studies

A final version of the Jasmax/Beca collaboration case study was presented and a final version of the case will be published on the BIMinNZ website at the end of February. Four additional case studies are currently underway as part of the fourth tranche of case studies and will be presented to the committee at the coming meetings.



7. MBIE Update

MBIE's Building System Performance (BSP) branch aim to work to improve their regulatory system with a focus on efficient systems that encourage innovation, while ensuring buildings are safe and durable. In the first quarter of the 2019 calendar year there will be a public consultation on a number of legislative changes as part of the Building System Legislative Reform Programme, the key areas of focus are Risk and Liability, Building Products and Occupational Regulation. The BSP also propose improvements to the Building Code with updates to take place Bi-Annually. The aim of the BSP is to concentrate on improving the system as a whole – through people, products, performance and processes.
